SHOW TERMS & CONDITIONS

APPROVALS-Show is sanctioned by N.R.C.H.A. and N.S.H.A. Classes will be run in accordance with the aforementioned rule books.

ELIGIBILITY: Class eligibility will be based on NRCHA recorded lifetime earnings and the NRCHA rulebook.

MEMBERSHIPS: Both owner and rider(s) must be current NRCHA membership a copy of current cards must be sent with entries. Memberships can be purchased at the show.

HORSE REGISTRATION: A copy of Horse's registration papers must be sent with entries.

AGED EVENT ENTRY INFORMATION:

1. **ENTRY DEADLINE:** Entries are due August 8th. A \$500 payment is due at time of entry. No other payments are necessary prior to the show. A \$25% late fee will be charged for horses entering after the deadline
DRAWS: Draws will be posted at the NSHA website, www.nationalstockhorse.com, on August 14th.
2. **SCRATCHES/CANCELLATIONS:**
 - a. A full refund will be issued to anybody submitting written entry cancellation to the show secretary before the entry deadline.
 - b. If written notice is submitted after the deadline but before the draw a veterinary note will be required and all monies less a \$150 scratch fee will be refunded.
 - c. After the draw \$500 deposit will be forfeited.
3. **SUBSTITUTIONS:** Substitutions will be allowed. A new entry form and proper paperwork will be required.
4. **OPEN ENTRIES** are automatically entered into all Open divisions for which they are eligible (Intermediate Open, Limited Open, Level One Limited Open). Open Money will be paid out 72% Open, 15% Intermediate Open, 8% Limited Open, 5% Level One Limited Open. 75% of entry fee goes to Pay Out.
5. **NON PRO ENTRIES** are automatically entered into all Non Pro divisions for which they are eligible (Intermediate Non Pro and Novice Non Pro only). Non Pro Money will be paid out 65% Non Pro, 25% Int. Non Pro, 10% Nov. Non Pro. 70% of entry fee goes to Pay Out. • Those entering the \$7500 Amateur Division do NOT need to be entered in the Non Pro Division. • The Non Pro Limited division follows the same rules as the Horse Show Non Pro Limited

HORSE SHOW ENTRY INFORMATION:

1. **ENTRY DEADLINE:** Entries are due August 14th. A one time late entry fee of \$30 will be charged for entries received after August 14th. Please DO NOT mail any entries after August 16th as they may not be received in time.
2. **DRAWS:** Draws will be done at 5:00 p.m. the evening before the class takes place. We will make every attempt to post them on the NSHA website.
3. **SCRATCHES:** Scratches made after the draw has been posted will not be refunded.

PAYMENT OF FEES:

1. **AGED EVENT ENTRIES** are required to send in a \$500 payment per division entered.
2. **HORSE SHOW ENTRIES** are not required to send in any payment at time of entry.
3. An open check or credit card number must be provided at the horse show office at the time of check-in. Any returned checks will be charged a \$50 NSF fee.
4. Credit cards can be used to pay any fees that are due. If you want to use this option please download and complete a Credit Card Authorization Form.

STALLS/HAUL-INS: Stalls must be reserved using a stall reservation form. Stall reservations are due on 8/14/17 and are \$210.00 a piece. If you are not renting a stall a \$25.00 haul in fee per horse, per day will be charged.

BEDDING: Please complete the pre-order form and submit with entries.

RV SPACES: RV spaces can be reserved using the RV Reservation form. Please complete the form and submit it and send to Shawn Martin, 28618 N 53rd St, Cave Creek, AZ 85331 or fax to 480-515-1496. Spaces are \$35 per night.

OFFICE HOURS: Office will open at 9 a.m. on Monday, August 21st.

Registrant further agrees to release and hold harmless NSHA, its employees, representatives, agents and anyone else working at the event who through negligence or carelessness otherwise might be liable in damages to registrant. This release and waiver of liability shall be binding on Registrant heirs, representatives, dependants, and successors of interest. I agree as a condition of acceptance of entry the National Stock Horse Association may use or assign photographs, videos, audios, cablecasts or other likeness of me and my horse taken during the course of competition for the promotion, coverage or benefit of the competition, sport or the NSHA. Those likenesses shall not be used to advertise a produced and they may not be used in such a way to jeopardize non pro/amateur status. I hereby expressly and irrevocably waive and release rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity or to misappropriation. I have the authority and hereby do, by making this entry, assume responsibility for and bind owner, rider and/or agenda to the terms and conditions of the Release and Waiver of Liability. I warrant that I am of legal age, or am the parent or legal guardian of the participant named above, and that I have read and fully understand the foregoing terms.
