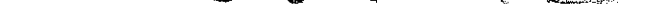

1 POINT PENALTIES

- A- Loss of working advantage
- C-Cow's head breaks the plane of the 1 point marker
- E-Changing sides of arena to turn cow
- L-For each length horse runs past cow
- P-Working out of position
- S-Slipping rein
- T-Failure to drive cow past middle marker on first run down the fence
after the cow is lined out (3 horse strides)
- W- Excessive hollering

2 POINT PENALTIES

- A-Going around corner of arena before turning cow
- B-In an open field turn animal gets within 3 feet of the end fence before being turned
- C-Failure to change sides after a circling turn prior to the first circle

3 POINT PENALTIES

- D-Dangerous Position
- E-Exhausting or overworking before circling cow

5 POINT PENALTIES

- A-Not getting a turn each way (5 points each way)
- B-Spurring or hitting in front of cinch at anytime or excessively whipping or spurring the horse.
- C-Blatent disobedience including kicking, biting, bucking, rearing and striking or obviously insubordinate
